The total limestone shipped outside the country in 2017 was 173,990 metric tons valued at US\$ 399,693 or Php 18,290,443. At least 70 percent of the produced crushed limestone of Lazi Bay Resources Development Inc. is shipped to Hongkong and only 30 percent goes to New Caledonia, a French territory in the South Pacific.

III. ENVIRONMENTAL PROTECTION AND MANAGEMENT

➤ Social Development Management Program

The approved budget requirement for the company's 2017 Annual SDMP is **P381,430.00**. The budget was apportioned into 75% for the implementation of livelihood assistance and infrastructure projects of the host community; 15% for the IEC program and 10% for the Development of Mining Technology and Geosciences program (DMTG).

➤ **Environmental Protection and Enhancement Programs**

The total amount committed by Lazi Bay Resources Development, Inc. for the implementation of their approved plans/program/project/activities under their Environmental Protection and Enhancement Programs (EPEP) is **P2,319.056.60**. EPEP refers to the comprehensive and strategic environmental management plan for the life of the mining project on which Annual EPEP's are based and implemented to achieve the environmental management objectives criteria and commitments including protection and rehabilitation of the disturbed environment.

➤ **Mining Forest Program**

The total number of seedlings planted by Lazi Bay Resources Development Inc. is 3,081 in more than 6.47 hectares of mine-out and other barren areas as of 2017.
